On Monday December 21, 2020 the Ontario government announced that a Province wide shutdown would be implemented at 12:01am on Saturday December 26th, 2020. This shutdown is intended to help interrupt or slow current community transmission, reduce mobility and allow the health care and public health systems that are reaching critical limits to recover briefly and catch-up. Presently, the restrictions are to remain in effect for our region until Saturday January 23rd, 2021. In consultation with the City of London and as an essential service provider, London Animal Care Centre will continue to provide services albeit in modified format. This document serves to outline the service model to be used throughout the pending Provincial shutdown.

Hours of Operation

Commencing Saturday December 26th, 2020 the London Animal Care Centre (LACC) shelter will be closed to the public until Saturday January 23rd, 2021 pending further instruction from the Province of Ontario.

Essential Staff will be on duty throughout our normal hours of operation while the shelter is <u>closed</u> to the public to respond to your inquiries. Please call 519-685-1330 for assistance.

LACC Service Adjustments

Dog & Cat Licensing

As the December 31st, 2020 expiry deadline for 2020 dog licenses and cat tags quickly approaches, we understand that pet owners are eager to ensure they remain compliant with the City of London by-law for 2021. The best way to ensure your pet(s) are registered with a current City of London license is to use our online renewal system found at <u>www.accpets.ca</u>. You may also visit this website to register a new pet with the City. LACC will also process all renewals sent in by mail.

LACC staff will be available via telephone **519-685-1330** during regular business hours to assist with any issues you may encounter while registering your pet(s).

AFTER 4:00pm on Thursday December 24th, 2020, PLEASE DO NOT ATTEND THE SHELTER FOR THIS SERVICE AS WE WILL BE CLOSED TO THE PUBLIC.

Shelter Operations (Stray intake, Adoptions, Lost Pets, Claims)

Animal care staff will remain on duty to ensure high level animal welfare, care and husbandry services continue.

Lost Pets – Pet Claims

Between the hours of 8:00am-4:00pm, LACC will be available to facilitate lost pet claims by appointment only. If you have lost your pet, please visit our Lost & Found page to view all animals currently in the shelter. These listings are updated regularly, so please check back often. You may also call the shelter to make inquiries. If it is determined your pet is at the shelter, please call in advance to make the necessary arrangements to claim your lost pet. Pet Adoptions

 LACC will be moving forward with pet adoptions using our Virtual Adoption Program. Stray Animal Intake (Dog, Cat, Other Domestic)

- Between the hours of 8:00am-4:00pm, LACC will be accepting <u>stray</u> community pets from the public **by appointment only.** Please call **519-685-1330** to make an appointment for stray animal delivery at the shelter. Those arriving at the shelter without an appointment will be asked to return to their vehicle to determine shelter availability to receive incoming animals.
- LACC is unable to accept <u>owned</u> pets for surrender / rehoming

Animal Control & By-law Enforcement

- LACC Animal Service Officers & Dispatch support staff will continue to respond to emergency and high priority calls. High priority/emergency calls include law enforcement assistance, injured or sick stray animals & wildlife, bite complaints and stray dogs at large.
- LACC Animal Service Officers have temporarily suspended 'in person' by-law enforcement activities for non-emergency by-law activity. These may include, leash law and licensing complaints, conflict mitigation scenarios, general by-law investigations and follow-up. Animal Service Officers will be addressing these concerns via telephone correspondence.
